Partner's History/Relationship with the Project:			
<p>The Christian Council of Ghana (CCG) is the unifying body of Christians in the country. Representing 26 member churches and three Christian organizations, the Council unites a common purpose among churches to work for achieving justice, unity, reconciliation, and the integrity of creation in all aspects of Ghanaian society. The Council is dedicated to work for an increased realization of social and economic rights of disadvantaged women, men and children in Ghana. The CCG has been an ecumenical partner of Global Ministries for many years. The Council is requested frequently to work with international and ecumenical advocacy organizations and research organizations on poverty alleviation work. One example of this would be the Millennium Development Goal Civil Society Secretariat on all platforms for health, education, and networks were hosted by the Council. In relationship with the Christian Church (Disciples of Christ), Ms. Joyce Larko Steiner, the Director of Programs and Advocacy of the Christian Council of Ghana, has contributed to the work of Global Ministries as an international board member.</p> <p>Over the years, the Programs department of the CCG has advocated and championed gender and human rights related issues, contributed in fighting against child trafficking, sex trafficking, and issues of sexuality and gender-based violence in the church. With support from the United Nations Population Fund, the CCG developed a manual addressing human rights violations against women in the church and addressing the spread of biblical misinterpretations on the role of women in the church. Through the support of Global Ministries, the CCG has projects to focusing on the United Nations Sustainable Development Goal #5, to achieve gender equality and the empowering of women and girls. These projects include the Smoked Fish Microcredit project, the education of girls, reproductive health, and advocacy programs for gender justice.</p> <p>After becoming one of the first countries to ratify the Convention on the Rights of a Child adopted by the United Nations Assembly, Ghana is fighting still for the rights of children and young people today. In 2008, the country passed a policy to support actions reducing the occurrence of child labor and human trafficking in Ghana. The Christian Council of Ghana began several projects to provide women and families with the opportunity to earn a sustainable income. Many families in this region must make the difficult decision between sending their children to school and sending their child to work. The Hope for Teens project is one way the CCG is supporting the government's decision to end child labor.</p>			
Description of Project			
Name of Project and Purpose:			

<p>The name of this project is Hope for Teens. This project is relatively new, created by CCG member church, the Methodist Church. The project provides vocational skill training and self-empowerment training for teenage mothers identified in Kaneshie, a community near Accra. The program began with a small number of women; however, it has grown as teenage mothers continuously request the church for this program. Through skills training workshops and mentorship, the program has helped teenage mothers in the Accra area find space for self-expression and wholeness.</p> <p>The project aims to teach young women with children in the vocational skills of dress making, hairdressing, and catering services. By giving young mothers the opportunity to earn a fair wage, they can support their children and immediate families. The project would assess the specific priorities and interests of the women to support them with startup funds, tools, and equipment to begin generating an income. The project also includes significant attention to the topics of sexual and gender-based violence perpetuated against them. As is the case in many countries, often acts of sexual and gender-based violence occur without being reported. Through group conversations and through a mentorship program, the program seeks to empower and inspire girls and to ensure their success will continue.</p>

<p>The target population of this project is to support teenage mothers and teenage girls without children from urban settings.</p>
<p>How many persons are/will be served? (<i>please give as specific a figure as possible</i>)?</p>
<p>Through the proposed project, the CCG will train and mentor 40 teenage mothers, and 20 teenage girls living in vulnerable housing. Additionally, the CCG will walk alongside ten mentors, who are older and active with the CCG, as they provide mentorship for the young women in the project.</p>

<ol style="list-style-type: none"> 1. Train the participating teenage girls on selected vocational skills 2. Improve the incomes of this group of participating teenage girls 3. Through mentorship and group conversations, emotionally and mentally empower and inspire girls
<p>Key Activities:</p>
<ol style="list-style-type: none"> 1. Provide training instruction and materials for the vocational skills of dress making, hairdressing, and catering services for 40 selected teenage mothers. 2. Organize two seminar series: one on sexual and reproductive health and the other on basic business management skills. 3. Organize a mentorship training program with ten selected women to mentor younger women in the project. 4. Provide startup materials/ capital for 10 selected teenage mothers
